DFR Approves Several Insurer Plans to Refund or Reduce Auto Insurance Premiums during Stay-Home Stay-Safe Order

Seventy auto insurance companies have filed plans to return premiums, pay dividends, or reduce their rates for Vermont policyholders due to reduced driving during the COVID-19 pandemic. These plans will amount to almost \$23 million in total savings for Vermonters. If your insurer has implemented a premium credit, dividend, or refund plan, you have received or can expect to receive a credit on your auto insurance statement, a dividend, a refund check, or a reduced rate when you renew your policy. Information about your insurer's plan is generally available on your insurer's website.
