DEFAULT JUDGMENT AND ORDER

I. FINDINGS OF FACT

- 1. Respondent Brandon Lewandowski ("Respondent") holds non-resident insurance producer license # 3165137.
- License # 3165137 was last renewed in 2021 and expires on March 31,
 2023.
 - 3. Respondent's resident state is Ohio.
- 4. On July 12, 2021, the Idaho Department of Insurance revoked Respondent's Idaho non-resident insurance producer license for failure to renew his Ohio resident insurance license and allowing it to lapse.
- 5. On October 21, 2021, the Washington Insurance Commissioner revoked Respondent's Washington non-resident insurance producer license for failing to report an administrative taken against respondent by another state, failing to respond to the Washington Insurance Commissioner, and due to revocation of his insurance license in another state.
- 6. On November 12, 2021, the Virginia State Corporation Commission issued an order revoking Respondent's Virginia resident insurance agent license for failure to report an administrative action taken against Respondent by another state.

- 7. On January 21, 2022, the Wisconsin Office of the Commissioner of Insurance issued an order revoking Respondent's non-resident intermediary insurance license following Respondent's failure to pay an administrative forfeiture previously assessed against Respondent for failure to report administrative actions taken against him by other states and for misstatements in his insurance application.
- 8. On April 6, 2022, the South Dakota Department of Labor and Regulation issued an order revoking Respondent's South Dakota non-resident insurance producer license for failure to respond timely to the South Dakota Division of Insurance, for failing to report an administration action against him, and due to the revocation of his insurance licenses in other states.
- 9. As of September 7, 2022 Respondent had not reported to the Commissioner the administrative actions taken against Respondent by Idaho, Washington, Virginia, Wisconsin, or South Dakota.
- 10. On September 9, 2022, the Insurance Division served upon Respondent the Petition for Revocation of License ("the Petition") and Notice of Right to Request Hearing ("the Notice") filed in the above-captioned matter.
- 11. As of the effective date of this Default Judgment and Order, more than 30 days after service of the Petition and Notice, no answer, request for a hearing, or other defense to the Petition has been received by the Insurance Division from Respondent.
- 12. More than 10 days have passed since the Insurance Division filed a motion for default judgment in the above-captioned matter and served the motion on Respondent.

II. CONCLUSIONS OF LAW

- 13. Because Idaho, Washington, Virginia, Wisconsin, and South Dakota have revoked Respondent's non-resident insurance licenses, revocation of Respondent's Vermont non-resident insurance producer license is authorized pursuant to 8 V.S.A. § 4804(a)(10).
- 14. Because Respondent failed to timely report to the Commissioner the administrative actions taken against Respondent by by Idaho, Washington, Virginia, Wisconsin, or South Dakota, Respondent violated 8 V.S.A. § 48130 and revocation of Respondent's Vermont non-resident insurance producer license is authorized pursuant to 8 V.S.A. § 4804(a)(3).
- 15. Because no answer, request for a hearing, or other defense to the Petition has been received by the Insurance Division from Respondent, and as more than 10 days have passed since the Insurance Division filed a motion for default judgment, the allegations contained in the Petition are treated as proven and a default judgment may be entered in the above-captioned matter pursuant to Sections 1.04(H) and (V) of the Vermont Department of Financial Regulation Administrative Procedures.

III. ORDER

16. Based on the findings of fact and conclusions of law set forth above, a default judgment is entered against Respondent, and it is hereby ordered that the non-resident insurance producer license # 3165137 of Respondent Brandon Lewandowski is revoked, effective immediately.
